Meeting was requested to start at7pm and agreed by members. Attendees: Shawn Gerber, Darlene Knapp, Kathy Habern, Beth Stoller, Michael Gray and Barb Sinn.

7:25pm Meeting began with a Prayer by Shawn Gerber. Meeting called to order by Michael Gray and seconded by Beth Stoller at 7:25pm. Motion to accept and Pay Bills motion made by Darlene Knapp and seconded by Kathy Habern.

Barb Sinn brought up the idea to make trash collection in the village added on to sewer bills requiring all Village residents to have trash removal services. This would require a year long contract with service being approximately \$66/month. Barb will gain more information from Real Waste before next meeting, stating that this would alleviate the dumpsters in Spring/Fall and also be approximately \$20 cheaper per resident than same service currently with a large pickup of items at the beginning of the month for households.

Kathy Habern stated that she has painted all current sewer lids unless someone sees others that require paint.

Darlene Knapp stated that Nick Mansfield has turned in his keys and resignation letter to her. Also stated that the tree at the old Pease property is currently on Windstream lines and they called the hazard in to Windstream who stated that they would be out on Wed between 7-7. She also stated that the Vielma property is now vacated.

Michael Gray reported that he had a map and paperwork proving that the Railroad St to the old Tavern was indeed listed on his map and turned it into Shawn Gerber so that the solicitor could finish his paperwork to stop reconstruction of Village owned street by Mr. Garret Brenninger. Michael also asked if he had permission from Stollers to place the old snow plow on their lot with a for sale sign and Beth Stoller gave her permission.

Beth Stoller-nothing new on the shipping of the slide purchased by the village. Also reported that Julia Klinger Hulsmeyer requested to use the shelter house for a family reunion. Council agreed on the use for this reunion of the shelter house.

Shawn Gerber stated that Ward Construction should be starting paving project of Second St as soon as possible. Vantage update will be at next month's meeting and that they would like to build 2 houses. County Mayors meeting is next week for the County. Grant monies are available from the railroad for Playground improvements and would need a grant written to see if Latty could receive any monies from this grant . Beth Stoller stated that she would check to see if she could complete this. Bidlack property needs cleanup with lift being moved from the street encroachment. Need solicitor to draw up paperwork to have this area cleaned up asap. Fill open Council Position at next meeting. Latty Village sign needs to be troubleshooted for current updates and he will contact West Bend News for help on this matter. Trick or treat needs date set. Mower is currently in the shop awaiting parts but is under warranty. Michael Gray will check in with Ace on repairs
